California Alliance of Child and Family Services Member Agencies Receive Behavioral Health Care Workforce Awards

Sacramento, CA - The California Alliance of Child and Family Services (CA Alliance) is thrilled to announce that five of its members have been awarded grants to support their behavioral healthcare workforce through a program offered by the Department of Health Care Services (DHCS). A combined total of \$2.895 million in funding was awarded to 39 agencies to support the next generation of behavioral health care workers through mentored internship.

The awards, announced on April 25th, by California Governor Gavin Newsom, are part of a larger effort to address the state's shortage of mental health professionals and improve access to quality behavioral health services for all Californians, particularly those in underserved communities.

In the announcement from the Governor's Office, Governor Newsom said of the awarded grants, "California needs more health care workers and through this mentorship program, we are supporting young professionals at the start of their careers and equipping them with the skills needed to help tackle the opioid crisis. The grants going out today will help ensure that our health care workforce better reflects the communities they serve and help expand access to critical behavioral health services for all Californians."

With these awards, California is taking an important step toward building a strong, sustainable behavioral health workforce that can meet the growing demand for services throughout the state. Congratulations to all the awardees, including our members at the California Alliance of Child and Family Services, for their exceptional work and dedication to improving the lives of Californians.
